- Option 2: Select subject immersion** - core curriculum in the morning, 8:30 to 11:45 a.m., 5 days a week, PLUS your choice of one to four subject-immersion afternoons a week, along with lunch and rest, from 11:45 a.m. to 2:30 p.m. Please check days to enroll. See accompanying schedule for tuition.
 - Monday afternoons: Language Arts, Literature and Spanish
 - Tuesday afternoons: Social Studies, Culture and Community
 - Wednesday afternoons: Motor Development and Movement
 - Thursday afternoons: Hands-on Science
 - Friday afternoons: Everyday Math

AFTERNOON PRE-K TUITION SCHEDULE & PAYMENT PLANS

The online enrollment for Pre-kindergarten covers only the morning portion that all students will attend. The accompanying enrollment form for the afternoon options must be completed manually and sent to Patty Duval at the Hillcrest campus. Enrollment forms should be submitted with an initial tuition deposit of \$200, which will allow us to gauge commitment levels and hire faculty for the appropriate number of enrolled students.

Tuition will be due according to the same payment plan you selected for your morning tuition with the same due dates. The tuition schedule for 2010-2011 is as follows:
